Priority will be given to teams with the earliest date of application. Applications must include the names of all players and two umpires (who may also be players.) Only those players listed will be permitted to play for that team in the Guru Nanak Hockey Tournament. Changes must be approved in writing by the tournament committee before June 10, 2009. No applications will be accepted after June 10, 2009.

The tournament committee reserves the right to reject any application by returning the entry fee. ALL DOMESTIC PLAYERS MUST be members of the Field Hockey Association of America. Foreign teams should have insurance which is valid in the United States.

1 Accomodation:
